PREAMBLE:

As per Mineral Policy-2003 (GOG), the State Government has decided to make the working of Petrography & Mineral Chemistry Laboratory (presently under the administrative control and supervision of Commissionerate of Geology & Mining) in professional manner and to develop the facilities of Referral level (Standard) at this Laboratory so as to provide prompt services regarding research, testing and analysis. Also, this Laboratory should obtain accreditation from National Accreditation Board for Testing and Calibration Laboratories (NABL), Government of India.

For implementing above decisions, the State Government has passed Resolution No: PaRaCh-1005-4327-Ch dated 21.11.2005 so as to provide independent status to above mentioned laboratory and to set up the Laboratory as an Autonomous Body. Therefore, the state government has decided to register the same under the provisions of Societies Registration Act, 1860 and Bombay Public Trust Act, 1950 and issued above resolution.

To facilitate registration an autonomous laboratory, the above GR is amended as under:

RESOLUTION :

In pursuance to the above Resolution, the "Petrography & Mineral Chemistry Laboratory Society-PMCL" is to be converted in to Autonomous Body (society) under the provisions of Societies Registration Act, 1860 and Bombay Public Trust Act, 1950 namely "Gujarat Mineral Research & Development Society - GMRD".

The "GMRD" shall function as an Autonomous Body in the field of laboratory research, analysis & testing of minerals and to provide services to the industries of mineral sector and related to its allied activities. GMRD shall provide testing certificates for mineral based products and shall get approval from National Accreditation Board for Testing and Calibration Laboratories (NABL), Government of India.

OBJECTIVES :

The "Gujarat Mineral Research & Development Society - GMRD" shall have, in general, the following aims and objectives:

- (1) To undertake research and development in the field of mineral, analysis & testing of ores, rocks & mineral samples submitted by Department of Geology & Mining, public sector undertakings, private sector mineral industries, research institutions, laboratories etc. so as to assess quality of Ores, minerals by chemical, physical testing and instrumental analysis.
- (2) To undertake the analysis & testing of mineral samples submitted by Department of Geology & Mining, public sector undertakings, private sector mineral industries, research institutions, laboratories etc. so as to assess quality of Ores, minerals by chemical, physical testing and instrumental analysis on "no profit no loss basis".
- (3) To provide certificate on the basis of testing and analysis, to exporters of mineral based products after obtaining accreditation from National Accreditation Board for Testing and Calibration Laboratories (NABL).
- (4) To identify the mineral and associated impurities with the help of modern instruments.
- (5) To procure modern testing equipments from Indian or international market like X-Ray Diffractometer, Atomic Absorption Spectrophotometer, Differential Thermal Analyzer-cum-Thermal Gravimetric Analyzer, Infra Red Spectrophotometer, Particle Size Analyzer, Sedimentation Balance, Modern Microscope with Photo micrographic attachment and such other equipments so as to facilitate testing of various parameters of the mineral properties.
- (6) To establish and train remote sensing wing for quick appraisal of geological horizons, tectonics, lithology etc. with help from Gujarat Mineral Development Corporation and private promoters.
- (7) To make available the geological information to entrepreneurs, lease-holders and people active in the mineral development.
- (8) To initiate action to strengthen and upgrade the laboratory and provide a lead in starting R & D.
- (9) To do all other acts and things conducive for the attainment of the above object in most efficient manner possible and such other activities which are relevant to fulfill the objectives of the GMRD;

The detailed objectives on the above line may be included in Memorandum and Bye-laws for the society.

Office of Commissioner, Geology and Mining will prepare Memorandum of Association, Bye - Laws etc. and shall take further action for registration of society.

Members:

The Governing Body shall consist of 12 members and there shall not be at any time less than 7 or more than 12 members. The Managing Director, Gujarat Mineral Development Corporation Ltd. (GMDC) shall be chairman of proposed GMRD.
